What information we collect, use, and why

We collect or use the following information to **provide services and goods, including delivery:**

- Names and contact details
- Addresses
- Date of birth
- Purchase or account history
- Health and safety information
- Account information
- Photographs or video recordings
- Records of meetings and decisions
- Identification documents
- Information relating to compliments or complaints

We collect or use the following information for **the operation of customer accounts and guarantees:**

- Names and contact details
- Addresses
- Purchase history
- Marketing preferences

We collect or use the following information for **service updates or marketing purposes:**

- Names and contact details
- Addresses
- Marketing preferences
- Location data

- Records of consent, where appropriate

We collect or use the following information for **recruitment purposes**:

- Contact details (eg name, address, telephone number or personal email address)
- Date of birth
- National Insurance number
- Copies of passports or other photo ID
- Employment history (eg job application, employment references or secondary employment)
- Education history (eg qualifications)
- Right to work information

We collect or use the following personal information for **dealing with queries, complaints or claims**:

- Names and contact details
- Address
- Account information
- Purchase or service history
- Customer or client accounts and records

We collect or use the following information to **CCTV**:

Lawful bases and data protection rights

How long we keep information

We only keep personal data for as long as we need it. There aren't any set time limits because it depends on the situation.

When we no longer need personal data for the reason we collected it, we destroy it securely or anonymise it.

If a law says that we must keep certain records for a set period, then we will do so.
